Information obligation of the controller pursuant to Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to processing of personal data and on the free movement of such data (hereinafter referred to as "the Regulation") in accordance with § Section 19 of Act No. 18/2018 Coll. on the Protection of Personal Data (hereinafter referred to as the "Act").

INFORMATION ABOUT THE CONTROLLER

This information obligation describes the principles for the processing of personal data of business and contractual partners and customers (hereinafter referred to as "customer") and visitors to the website www.uranpres.sk (hereinafter referred to as "website"). URANPRES, spol. s r.o. acts as the controller in the processing of personal data and determines for what purpose and by what means the processing of personal data will take place.

DATA PROTECTION COMMISSIONER

Supervision of personal data protection (within the meaning of §44 of Act No. 18/2018 Coll. Ing. Petra Benková, zo@ekofinas.sk and who can be contacted by any data subject whose personal data is processed in our company.

CATEGORIES OF DATA PROCESSED

Data provided by business and contractual partners and customers. Only the personal data that you yourself provide us with when entering into a business or contractual relationship, when placing an order for services in person, by mail or by telephone or when making a complaint for services are processed. These data include in particular first and last name, address, telephone number, email address and payment details. Data collected via cookies. If you have enabled the storage of cookies in your browser and agree to their use, URANPRES, spol. s r.o. obtains data about your visit to the website, products viewed and other activity on the website.

THE PURPOSE OF THE PROCESSING OF THE DATA PROVIDED

We use your name and surname, contact details and payment details to fulfil obligations arising from a business or contractual relationship or to process your order for services. Data processing in this case includes all activities from the pre-contractual relationship, the signing of the contract, the receipt and registration of the service order to the actual delivery of the service or the performance of the subject of the contract. If the data is not provided, the Operator cannot conclude a business contract or accept and process your order.

We use your first and last name and contact details to process your service complaint.

The data processing in this case includes all activities from the registration of the service complaint, processing of the complaint according to the complaint procedure to its closure. If the data is not provided, the Operator - URANPRES, spol. s r.o. cannot accept and process your complaint.

Data from social networks (FB, Twitter, Instagram). If you use one of the social networks to contact our company, you also give URANPRES, spol. s r.o. access to your public profile, date of birth, current location and email address. Your public profile on a social network includes your first and last name, profile picture, age category, gender and other public information according to your preferences.

For better targeting of advertising and promotion of the Operator, URANPRES, spol. s r.o. processes data on visits to the website, services viewed and other activity on the website when using cookies. Processing is only possible on the basis of your consent to the use of the relevant cookies. This consent is completely voluntary. On the basis of the data obtained, URANPRES, spol. s r.o. obtains analyses of user preferences of the website. After evaluating this data, it is possible to better target advertising or adapt the content of the website to what you are really interested in and what you are looking for. THE LEGAL BASIS FOR PROCESSING YOUR PERSONAL DATA

The Controller - URANPRES, spol. s r.o. processes your personal data mainly for the purpose of fulfilling the contractual relationship that you have entered into with us by concluding a business contract or by issuing an order for services.

Other legal bases for processing your personal data are the fulfilment of legal obligations, our other legitimate interests and your consent to the processing of your personal data.

ACCESS TO PERSONAL DATA

In the first place, personal data are processed by authorised persons of the Controller. All persons who have access to personal data are bound to confidentiality and this obligation continues even after the end of their cooperation with the Controller - URANPRES, spol. s r.o.

URANPRES, spol. s r.o. as the controller entrusts the processing of personal data to other entities, as so-called processors. An intermediary is a contractual party that processes personal data for the Controller for the purposes and in the manner specified by the Controller - URANPRES, spol. s r.o.

Furthermore, personal data may be disclosed to supervisory, state or judicial authorities if required by the relevant law. Where your consent is required for processing, we only pass on data to processors if you have given your consent.

DATA PROCESSING TIME LIMIT

The Controller - URANPRES, spol. s r.o. processes personal data for the purpose of fulfilling the subject of the contract for the entire duration of the contractual relationship. By law, the Controller subsequently stores certain data contained in accounting documents.

Data collected for marketing purposes via cookies are processed by the Controller for the duration of the consent to the use of cookies, i.e. for as long as you allow the storage of

cookies in your browser, or until an objection is raised against the processing of your data for this purpose.

Further processing of personal data beyond the aforementioned time limits shall only be carried out by the Data Controller if this is necessary to comply with the obligations arising from the legal regulations applicable to the Data Controller.

RIGHTS OF THE PERSON CONCERNED

As a data subject whose personal data we process, you may, pursuant to Art. 18/2018 Coll. on the protection of personal data, you can exercise your rights to:

The right to access your personal data - and to request confirmation as to whether your personal data is being processed by us as the Data Controller.

The right to rectification of personal data if it is inaccurate or incomplete in any way. Only in the case of up-to-date data can the Data Controller correctly fulfil the subject of the contract.

The right to the erasure of personal data (the so-called right to be forgotten) or their limited processing if they are no longer necessary for the stated purposes or if the Data Controller no longer has a legitimate reason to process the personal data, including in cases where you do not consent to their further processing. The Data Controller will delete your data in whole or in part when the above conditions are met.

The right to transfer personal data obtained on the basis of your consent from the Data Controller to another entity, where the Data Controller will transfer your personal data in a commonly used format to you or to another controller according to your wishes.

Right to withdraw consent - if we process your personal data on the basis of your consent, you have the right to withdraw your consent at any time. You can withdraw your consent electronically, by contacting us at our contact address or by notifying us in writing that you have withdrawn your consent.

Right to restriction of processing - in certain circumstances you are entitled to ask us to stop using your personal data. These include, for example, where you believe that the personal data we hold about you may be inaccurate or where you believe that we no longer need to use your personal data.

Right to object - you have the right to object to the processing of data that is based on our

legitimate interests. If we do not have a compelling legitimate ground for processing and you object, we will no longer process your data.

The right to file a petition to initiate personal data protection proceedings - if you believe that
